**PROPOSED OHIO RULE - FILLING, GRADING AND
EXCAVATING, BUILDING, DRILLING OR MINING ON FORMER
HAZARDOUS OR SOLID WASTE FACILITY SITES**

The Ohio Environmental Protection Agency has proposed a revised Rule related to filling, grading, excavating, building, drilling or mining on land where a hazardous waste facility or solid waste facility was operated. The Rule was originally put forth in 1988. Changes include:

- The self-implementation timeframe for sampling authorizations was changed from eight days to fifteen days.
- A requirement to submit letters of intent to the local board of health, local governments of the general purpose or political subdivisions where the site is located, the local zoning authority, the local solid waste management district (if applicable), and the local fire department.
- The application was expanded to require an explanation of how the applicant will maintain the integrity of the facility throughout the activities and a description of applicable aspects of the facility design plan like the description required of modern and historic facilities pursuant to rule 3745-513-300.

Rulemaking schedule - At this time, the Agency has solicited input on these draft rule revisions. Ohio EPA is required by section 121.39(D) of the Revised Code to contact potentially affected parties prior to adopting rule changes. At the close of the interested party comment period, the Agency will review the comments and make necessary changes to the rules. The Agency will then file proposed rules with the Joint Committee on Agency Rule Review, the Legislative Service Commission and the Secretary of State.
