OHIO EPA IS PROPOSING AMENDMENTS TO ITS SUCCESSFUL VOLUNTARY ACTION PROGRAM

The Ohio EPA has recently announced that they are proposing rule changes to their successful Voluntary Action Program. The Program makes use of Certified Professionals to remediate sites with similar programs implemented in other states such as New Jersey, Connecticut and Massachusetts.

The Division of Environmental Response and Revitalization has proposed revisions to rule 11 Voluntary Action Program Remediation in Chapter 3745-300 of the Ohio Administrative Code (OAC) to Joint Committee on Agency Rule Review (JCARR). The purpose of this rulemaking is to amend several subparagraphs of paragraph (D) to allow the Director of Ohio EPA to deny a request for pathway omission.

Ohio EPA will be holding a public hearing on the revised rules on June 7th, 2018, at 10:30 am at Ohio EPA Central office, Columbus, Ohio. Please see the public hearing notice, response to comments, proposed rule language and the Business Impact Analysis (Linked below) for information on the changes and how to submit comments/attend the hearing.
