**NOTICE OF INTENT TO REMEDIATE  
TO AN ENVIRONMENTAL STANDARD**

*Pursuant to the Land Recycling and Environmental Remediation Standards Act, the act of May 19, 1995, Act No. 1995-2 (the "Act"), notice is hereby given that Defense Realty L.L.C. (Owner) has submitted to the Pennsylvania Department of Environmental Protection (PADEP) a Notice of Intent to Remediate (NIR) for a site located at 2800 South 20<sup>th</sup> Street, Philadelphia, PA. (the Site). This NIR states that the Site has been found to contain groundwater impacts. The Remediator has indicated that the proposed remediation measures will be a demonstration of a Site-Specific Standard. The proposed future use of the property will be either commercial or residential.*

*The Act provides for a 30-day public comment period for site-specific standard remediations. The 30-day comment period is hereby initiated with the publication of this notice. Until 11/16/2007, the City of Philadelphia may submit a request to the Remediator to be involved in the development of the remediation and reuse plans for the site. The City of Philadelphia may also submit a request to the Remediator during this 30-day comment period to develop and implement a public involvement plan. Copies of these requests and of any comments should also be submitted to the Pennsylvania Department of Environmental Protection, Southeast Regional Office, Environmental Cleanup Program, 2 East Main Street, Norristown, PA 19401, Attention: Mr. Walter Payne, P.G.*
