FROM PHILADELPHIA, AND SOUTH JERSEY

- Take Schuylkill Expressway (I-76) to King of Prussia/ Norristown Exit #329
- At light, go straight on to Henderson Road (at Exxon Station)
- Go Two Lights to Church Road, and Turn Left onto West Church Road.
- RT Environmental Services is at 215 West Church Road (Same Location as Sweat Gym), Building with Flagpoles out front.
- Main Parking Lot is in Rear, Enter Lobby and take Elevator to Third (3rd) Floor.

FROM PENNSYLVANIA TURNPIKE EAST OF NORRISTOWN, NORTHEAST EXTENSION AND CENTRAL/ NORTH JERSEY

- Take I-476 South (Blue Route)
- To I-76 West (Schuylkill Expy) toward Valley Forge
- Exit at King of Prussia / Norristown Exit 329
- At light, Go straight on to Henderson Road (at Exxon Station)
- Go Two Lights to Church Road, and Turn Left onto West Church Road.
- RT Environmental Services is at 215 West Church Road (Same Location as Sweat Gym), Building with Flagpoles out front.
- Main Parking Lot is in Rear, Enter Lobby and take Elevator to Third (3rd) Floor.

FROM EASTBOUND PENNSYLVANIA TURNPIKE WEST OF VALLEY FORGE

- From Points West of Valley Forge, Take the Eastern Pennsylvania Turnpike, and Exit at Valley Forge (Exit 24, I-76).
- After Paying Tolls, Take 2nd Exit to US 202 North.
- After Crossing over Schuylkill Expressway, Keep to Right, and Turn Right on South Gulph Road (at Best Western).
- Continue on South Gulph Road until Light at Brooks Road, Turn Left at Church Road (several hundred feet to the Left after Traffic Light at Brooks Road).
- Continue on Church Road approximately 1 ½ mile, after passing over a rise, look for 215 Building, with Flagpoles out front, and Sweat Gym Direction Sign at Entrance.
- Main Parking Lot is in the Rear of the Building; Enter Lobby and Take Elevator to Third (3) Floor.

I-95 South

Take Route I-95 South to Route 322 East/Commodore Barry Bridge exit. Cross Bridge into New Jersey. Proceed on Route 322 East approximately 2 miles to Route 295 South. Take Route 295 South for 1 mile to Exit 10. Center Square Road/Swedesboro. Turn right at top of exit ramp and go approximately 400 yards to Heron Drive and the entrance to the Pureland Industrial Complex. Turn right onto Heron Drive and proceed 400 yards to Building 510 on the right-hand side. Follow the drive straight back and around to Suite 306.

Route 476 (Blue Route)

Take Route 476 South to Route I-95 South. Follow the directions above from Route I-95 South.

New Jersey Turnpike

Take New Jersey Turnpike to Exit 2. Route 322 West to Route 295 South. Take Route 295 South for 1 mile to Exit 10, Center Square Road/Swedesboro. Turn right at top of exit ramp and go approximately 400 yards to Heron Drive and the entrance to the Pureland Industrial Complex. Turn right onto Heron Drive and proceed 400 yards to Building 510 on the right-hand side. Follow the drive straight back and around to Suite 306.

Delaware Memorial Bridge

Cross Bridge into New Jersey. Take Route 295 North to Exit 10. Turn left at top of exit ramp and go approximately 600 yards to Heron Drive and the entrance to the Pureland Industrial Complex. Turn right onto Heron Drive and proceed 400 yards to Building 510 on the right-hand side. Follow the drive straight back and around to Suite 306.
